Mr. Marriner pleaded guilty to the charge, Time Turner was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and pursuant to GAR 72, before any future nomination will be accepted.</p> <p>Deltora Quest underwent a post-race veterinary examination after falling after the finishing line and was found to have a right flexor tendon injury.
