Enzo's Girl, Jealous Again and Chuck Attack collided approaching the first turn, checking Enzo's Girl and Chuck Attack and severely checking College Girl and Jealous Again. Hill Top and Chuck Attack collided on the first turn, checking Hill Top. See Me Bespoked contacted the running rail approaching the home turn. College Girl raced wide on the home turn.
