Stewards deemed the performance unsatisfactory, acting in accordance with GAR 71, Victoria Libby must perform a Satisfactory Trial pursuant to GAR 72, before any future nomination will be accepted.</p> <p>Tinker Cindy underwent a post-race veterinary examination and was found to have a right back muscle injury. A 60 day stand down period was imposed.</p> <p>Pennine Way underwent a post-race veterinary examination and was found to have a right groin muscle injury. A 10 day stand down period was imposed. Stewards spoke to trainer, Mr John Musselwhite regarding the greyhounds performance. In accordance with GAR 75 (1), the Stewards requested Mr Musselwhite to report as soon as practicable anything that may have affected the running of Pennine Way in the event, which was not noted by Stewards during or immediately after the event.</p>
