Stewards will require a veterinary certificate pursuant to GAR 20(3)(v) before any future nomination will be accepted.</p> <p>A pre-race sample was taken from Patricia's Luck.</p> <p>Titanium Lass and Blair's Tulip were slow to begin.</p> <p>Huntly Flyer crossed to the outside soon after the start checking Jocularly. Patricia's Luck and Gypsy Play collided soon after the start. Patricia's Luck turned its head outwards soon after the start. Huntly Flyer and Jocularly collided at the 275m mark. Patricia's Luck, Huntly Flyer and Blair's Tulip collided at the 250m mark and again at the 200m mark. Patricia's Luck and Gypsy Play collided at the 150m mark.</p> <p>Patricia's Luck underwent a post-race veterinary examination and was re-examined following race 8. Stewards obtained details from the Satisfactory Trial conducted of 20 April, 2021 and after viewing the Youtube vision of the Trial, Stewards were satisfied the greyhound did not race with blinkers and amended Fastrack accordingly.</p>
