Race 1

My Amelda Rose crossed in soon after the start. Midnight Pompeii checked off Flying Torpedo at the 250m mark. Bruree Man turned its head inwards approaching the winning post.

Bruree Man underwent a post-race veterinary examination and was found to have a right hock sprain and a right foreleg toe injury. A 10 day stand down period was imposed. Stewards spoke to trainer, Mr Edmund Dollery regarding the racing manners of Bruree Man approaching the winning post. After hearing evidence from Mr Dollery, viewing all the available race footage and taking into account the injuries sustained, a warning was issued regarding the greyhound's racing manners approaching the winning post.

Mr Donald Jarvis informed Stewards that he had a vehicle breakdown on–route to the track. Mr Kenworthy pleaded guilty to the charge, False Alarm was found guilty and suspended for 28 days at Healesville and must perform a Satisfactory Trial in accordance with GAR 69A(2) and pursuant to GAR 72, before any future nomination will be accepted.
