#### Race 1

He's A Rebel and Kraken Rover collided soon after the start severely checking He's A Rebel. Kraken Rover, Change Of Habit and Next Teardrop collided approaching the first turn checking Change Of Habit. He's A Rebel checked off Princess Vegas on the first turn. Coalville Jewel and Kraken Rover collided on the first turn severely checking Coalville Jewel. Mystical Heist and All Inn Cash collided on the home turn. Next Teardrop crossed to the outside on the home turn checking Change Of Habit. Next Teardrop raced wide on the home turn, entering the home straight and again in the home straight.

Col Cowboy and Itchy Kaala collided approaching the home turn checking Col Cowboy. Suntanned and Itchy Kaala collided several times in the home straight. Miss Martina and Sonny Cabang raced wide in the home straight.

Sambar Chief, Rio Baskin and Westcott Bale collided on the first turn and again approaching the home turn checking Rio Baskin. Sambar Chief and Lisa Be Naughty collided entering the home straight. Wescott Bale turned its head inwards and visibly eased in the home straight, again approaching the winning post and collided with Lisa Be Naughty.

Nightcore underwent a post-race veterinary examination at the trainers request and was found to have a lacerated antebrachium. A 10 day stand down period was imposed.

Westcott Bale underwent a post-race veterinary examination and was found to have a cervico-thoratic injury. A 3 day stand down period was imposed.

Stewards spoke to Mr Brian Fothergill, the trainer of Westcott Bale regarding the greyhound's racing manners in the home straight. Acting under the provisions of GAR 69A(1) Westcott Bale was charged with failing to pursue the lure with due commitment. Mr Fothergill pleaded guilty to the charge, Westcott Bale was found guilty and suspended for 28 days at Shepparton and must perform a Satisfactory Trial in accordance with GAR 69A(2) and pursuant to GAR 72, before any future nomination will be accepted.

#### Race 5
