Sold By Sticker crossed to the rail approaching the first turn checking Tails Of Woe and severely checking Mikado Gal. Quincee Bale and Basin Betty collided on the first turn checking Quincee Bale and Tails Of Woe, causing Varden Bale to check off Tails Of Woe severely checking Tails Of Woe, Warden Bale and Mikado Gal; all three greyhounds raced wide as a result. Varden Bale checked off Quincee Bale on the home turn.

Sold By Sticker underwent a post-race veterinary examination due to an incident in the catching pen and was found to have a right carpal sprain. A 5 day stand down period was imposed.
