Big Lug lost ground from the second turn. Kiwi Billy and Yussuf Bale collided on the third turn.

Big Lug underwent a post-race veterinary examination and was found to have injuries to the left shoulder muscle, right triangle muscle and an abrasion to the right stopper. A 10 day stand down period was imposed. Stewards spoke to trainer, Mr Brad Sands regarding the greyhound's racing manners approaching the first turn. Acting under the provisions of GAR 69B (1), Big Lug was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Sands pleaded guilty to the charge, Big Lug was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and pursuant to GAR 72, before any future nomination will be accepted.

Kiwi Billy underwent a post-race veterinary examination and was found to have shin soreness to both front legs. A 7 day stand down period was imposed. Stewards spoke to trainer, Mr Steven Spoljaric regarding the greyhound's racing manners. After hearing evidence from Mr Spoljaric, viewing all the available race footage and acting on their observations, a warning was issued regarding the greyhound's racing manners on the second turn.

Hello Lovely underwent a post-race veterinary examination and was found to have a left groin muscle injury and an abrasion to on the right carpal. A 7 day stand down period was imposed.

There was no head-on vision available for this race

Rio Baskin visibly eased, turned it's head outward and collided with Boes Bambino approaching the home turn, severely checking both greyhounds. Rio Baskin and Boes Bambino collided in the home straight checking Boes Bambino.</p> <p>Rio Baskin underwent a post-race veterinary examination and was found to have an injury to the left stopper. A 10 day stand down period was imposed. Stewards spoke to representative, Mr John Boreland regarding the greyhounds racing manners approaching the home turn. Acting under the provisions of GAR 69B (1), Rio Baskin was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Boreland pleaded guilty to the charge, Rio Baskin was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and pursuant to GAR 72, before any future nomination will be accepted.</p> <p>Boes Bambino underwent a post-race veterinary examination - no apparent injury was reported. Trainer, Mr Victor Gay declined his option the have the greyhound re-vetted. Stewards spoke to Mr Gay regarding the greyhound's racing manners approaching the home turn. Acting under the provisions of GAR 69A(1) Boes Bambino was charged with failing to pursue the lure with due commitment. Mr Gay pleaded guilty to the charge, Boes Bambino was found guilty and suspended for 28 days at Cranbourne and must perform a Satisfactory Trial in accordance with GAR 69A (2) and pursuant to GAR 72, before any future nomination will be accepted.</p> <p>There was no head-on vision available for this race.</p>

Cooped Up – Failed To Chase (injury) - Field of 6, Distance 311m, Weight 31.1kg, Box 8, Placed 3rd, Time Run 18.06 - Comment: Cleared All Tracks.

From The Brink – 6 months - Field of 6, Distance 311m, Weight 36.3kg, Box 1, Placed 1st, Time Run 17.78 - Comment: Cleared All Tracks.
