Acting under the provisions of GAR 69B (1), Orson Avery was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Capuano pleaded guilty to the charge, Orson Avery was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and pursuant to GAR 72, before any future nomination will be accepted.

Love Long Time underwent a post-race veterinary examination - no apparent injury was reported.

Stewards spoke to Mr Gregory Berry, the trainer of Love Long Time regarding the greyhound's racing manners on the home turn. Acting under the provisions of GAR 69A(1) Love Long Time was charged with failing to pursue the lure with due commitment. Mr Berry pleaded guilty to the charge, Love Long Time was found guilty and suspended for 28 days at Bendigo and must perform a Satisfactory Trial in accordance with GAR 69A(2) and pursuant to GAR 72, before any future nomination will be accepted.

Mr Caulfield pleaded guilty to the charge, Evil Entry was found guilty and suspended for 3 months at all tracks and must perform a Satisfactory Trial in accordance with GAR 69A (2) and pursuant to GAR 72, before any future nomination will be accepted.
