Acting under the provisions of GAR 69A(1) Galloping Suzy was charged with failing to pursue the lure with due commitment. Ms. Lund pleaded guilty to the charge, Galloping Suzy was found guilty and suspended for 28 days at Healesville and must perform a Satisfactory Trial in accordance with GAR 69A (2) and pursuant to GAR 72, before any future nomination will be accepted. Ms. Lund advised Stewards that the greyhound will now be retired. A post-race sample was taken from Super Foot - winner of the event.
