Ronnie Armo was slow to begin.</p> <p>Tillotson visibly eased on the first turn. Ronnie Armo and Call Me Buddy collided approaching the home turn. Press On and Only Dream collided approaching the home turn checking Only Dream. Tillotson visibly eased on the home turn. Tillotson and Winlock At Large collided on the home turn and again in the home straight checking Winlock At Large.</p> <p>Winlock At Large underwent a post-race veterinary examination and was found to have a left triangle injury.
