Trainer, Mr Robert Weightman was fined \$100.</p> <p>A pre-race sample was taken from Cornish Lad.</p> <p>The first race was delayed by 1 minute due to arriving late to the boxes.</p> <p>Top Plain was slow to begin.</p> <p>Top Plain crossed out soon after the start. Cornish Lad and Iron Lad collided soon after the start. Cornish Lad checked off Iron Lad at the 250m mark.</p>

A 10 day stand down period was imposed. Trainer, Ms Katrina Evans was fined \$100.</p> <p>Booker and Natalia Lee collided soon after the start. Pure Claire, Booker and Natalia Lee collided at the 300m mark checking Booker. Explosive Way and Booker collided at the 250m mark checking Explosive Way. Explosive Way visibly eased at the 50m mark.</p> <p>Explosive Way underwent a post-race veterinary examination and was found to have a neck injury. A 7 day stand down period was imposed. Mr Duncan pleaded guilty to the charge, Chillout Cookie was found guilty and suspended for 28 days at Healesville and must perform a Satisfactory Trial in accordance with GAR 69A (2) and pursuant to GAR 72, before any future nomination will be accepted.</p>
