Mr Ward pleaded guilty to the charge, Glasgow Lass was found guilty and suspended for 28 days at Warrnambool and must perform a Satisfactory Trial in accordance with GAR 69(2) and GAR 72, before any future nomination will be accepted.

Mr Baulch pleaded guilty to the charge, Tin Town was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B(1) and GAR 72, before any future nomination will be accepted.
