A 7 day stand down period was imposed. Stewards spoke to Peter Frost, the trainer of Mallee Swan regarding the greyhound's racing manners in the home straight. Acting under the provisions of GAR 123 Mallee Swan was charged with marring. Mr Frost pleaded guilty to the charge, Mallee Swan was found guilty and suspended for 28 days at The Meadows and must perform a Satisfactory Trial in accordance with GAR 127(a) and pursuant to GAR 132, before any future nomination will be accepted.</p>
