After reviewing all available evidence, Stewards found doubt existed to whether Mepunga Tess had glanced the running rail on the second turn and therefore could not be comfortably satisfied it had offended under any rule, with Stewards not taking any further action.

Fabriola Ximenez - Late scratching at 15:07pm when trainer Andrea Dailly reported the greyhound to have an illness (GAR 76). A 10 day stand down period was imposed. Stewards will require a veterinary certificate pursuant to GAR 19(3)(w) before any future nomination will be accepted.
