Ms McMahon pleaded not guilty to the charge, Adrian was found guilty and suspended for 28 days at Traralgon and must perform a Satisfactory Trial in accordance with GAR 127(a) and pursuant to GAR 132, before any future nomination will be accepted.</p>

Mr Bye pleaded not guilty to the charge, Flywheel Bella was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Stewards spoke to Mr Samuel Bye (via telephone), the trainer of Flywheel Bella after they left the course today without Stewards permission following the event. Stewards issued Mr Bye with a warning pursuant to GAR 94(2).</p>
