Acting under the provisions of GAR 123 Kraken Chino was charged with marring. Mr Eyles pleaded guilty to the charge, Kraken Chino was found guilty and suspended for 28 days at Shepparton and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>

Acting under the provisions of GAR 125, Puffin Bluey was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Kenworthy pleaded guilty to the charge, Puffin Bluey was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Ellie Bliss lost ground on the first turn and underwent a post-race veterinary examination and was re-examined following race seven, no apparent injury could be detected.</p> <p>Stewards spoke to Trainer Mr Martin Taylor regarding the racing manners of Ellie Bliss approaching the first turn. After hearing evidence from Mr Taylor, viewing the available race footage and acting on their observations, a warning was issued regarding the greyhound's racing manners approaching the first turn.</p>
