Race 1 SKY RACING 6:27 pm 600m Mixed 6/7	A pre-race sample was taken from Tails Of Woe. Mahjong Bailey was slow to begin after being checked shortly after the start.
Race 2 TOPCAT VIDEO 6:47 pm 525m Grade 5	Bonnie Too Good was quick to begin. Downstream was slow to begin. Javi - checked off heels in the back straight and lost ground for the remainder of the event. Underwent a post-race veterinary examination and was reported to have injuries to the right hind calf and hamstring. A 7 day stand down period was issued. Trainer Marlene Schmidt advised Stewards the performance in tonight's event was out of character for the greyhound and expected a more forward showing. Ms Schmidt added that in her opinion the injury sustained and a recent drop in weight over several starts were likely contributing factors to the run. Stewards noted her comments.

Perfect Colour was checked on the second turn and lost ground for the remainder of the event. Underwent a post-race veterinary examination – no apparent injury was reported. A post-race sample was taken from Carry On Angel –the winner of the event.
Race 9 DOWNLOAD THE WATCHDOG APP 9:11 pm 525m Grade 5	A pre-race sample was taken from Tiberia Bale. In A Blue and Indy Juno were quick to begin. Courteous Reiko were slow to begin. A post-race sample was taken from Aston Tenge - winner of the event.
Race 10 KCR PET TRANSPORT 9:32 pm 525m Grade 5	A pre-race sample was taken from Soda Extreme. Big Braveheart improved onto the heels of Arlington when rounding the turn into the back straight, was severely checked and lost ground. Big Braveheart underwent a post-race veterinary examination and was re-examined following race 11 and was found to have a right shoulder, right calf and a right hamstring injury. A 10 day stand down period was imposed. Stewards spoke to Trainer Geoffrey Mitchell regarding the greyhound's racing manners in the early part of the back straight and throughout the remainder of the event. Acting under the provisions of GAR 125, Big Braveheart was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Geoffrey Mitchell pleaded guilty to the charge. Big Braveheart must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted. Arlington underwent a post-race veterinary examination – no apparent injury was reported.
Race 11 COOKES ELECTRICAL AND AIR CONDITIONING 9:55 pm 525m Grade 5	There were no racing incidents to report.
Race 12 TAB VENUE MODE 10:17 pm 525m Grade 5	Winlock Crewe was slow to begin. Raph City was checked off the heels approaching the first and fell as a result. Raph City underwent a post-race veterinary examination - no apparent injury could be detected.
