Oseye Bale was quick to begin. Masters On Metro was slow to begin.

Oseye Bale, Very Jiggling, Agnet Bale, Gamblin' Ways and McIvor Rusty collided on the first turn. Very Jiggling and Gamblin' Ways collided on the second turn. Oseye Bale checked off Masters On Metro approaching the home turn. Oseye Bale and Masters On Metro collided in the home straight.

Zurial Bale, Tzar's Ghost and McIvor Jill collided on the first turn checking Tzar's Ghost and Keenan Rocks. Keenan Rocks shifted out and collided with Zurial Bale on the first turn. Keenan Rocks turned its head outwards and marred Zurial Bale approaching the home turn. Balt's Flying and McIvor Jill collided entering the home straight.

Keenan Rocks underwent a post-race veterinary examination and was found to have a right triangle injury. A 5 day stand down period was imposed. Stewards spoke to Mr Wade Green, the trainer, regarding the greyhound's racing manners approaching the home turn. Acting under the provisions of GAR 69(1), Keenan Rocks was charged with marring. Mr. Green pleaded guilty to the charge and Keenan Rocks was suspended for 28 days at The Meadows and must perform a Satisfactory Trial in accordance with GAR 69(2) and pursuant to GAR 72, before any future nomination will be accepted. Mr Green also advised Stewards that he would be retiring the greyhound.

A pre-race sample was unable to be obtained from Zurial Bale, a post-race sample was subsequently

Aston Glow underwent a post-race veterinary examination and was re-examined following race 5. Aston Glow was found to have a left monkey, chest and hamstring injuries. A 21 day stand down period was imposed.

Starlight Dusty was suspended for 28 days at The Meadows and must perform a Satisfactory Trial in accordance with GAR 69(2) and pursuant to GAR 72, before any future nomination will be accepted.
