Mr Keel pleaded not guilty to the charge, Wizardry Things was found guilty and suspended for 28 days at Sandown Park and must perform a Satisfactory Trial in accordance with GAR 69(2) and pursuant to GAR 72, before any future nomination will be accepted.</p> <p>Tiggerlong Water underwent a post-race veterinary examination and was found to have a right shoulder injury and right shin soreness. A 14 day stand down period was imposed. Stewards spoke to Representative, Mr Correy Grenfell regarding the greyhounds racing manners on the home turn. Acting under the provisions of GAR 69B (1), Tiggerlong Water was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Grenfell pleaded not guilty to the charge, Tiggerlong Water was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and GAR 72, before any future nomination will be accepted.</p> <p>Spray On Billy underwent a post-race veterinary examination and was found to have a right wrist sprain. A 7 day stand down period was imposed. Stewards spoke to Trainer Mr Gary Cowcher regarding the greyhound's racing manners on the home turn and entering the home straight.
