After hearing evidence from Mr. Galea, viewing all the available race footage and acting on their observations, a warning was issued regarding the greyhound's racing manners entering the home straight. In arriving at their decision, Stewards also consulted with the On-Track Veterinarian regarding the injury found for this greyhound and were satisfied that this injury may have affected the greyhound's performance, particularly when shifting wide on the first turn.
