Acting under the provisions of GAR 69B (1), Queen Sal was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Salpigtidis pleaded guilty to the charge, Queen Sal was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and pursuant to GAR 72, before any future nomination will be accepted.
