Acting under the provisions of GAR 69A(1), Wilson's Way was charged with failing to pursue the lure with due commitment. Mr. O'Keeffe pleaded guilty to the charge and was suspended for 28 days at The Meadows and must perform a satisfactory trial in accordance with GAR 69A(2) and pursuant to GAR 72, before any future nomination will be accepted.
