A 3 day stand down period was imposed. Stewards spoke to Mr. Daniel Boots, the trainer of Hill Top regarding the greyhound's racing manners in the home straight. Acting under the provisions of GAR 69A(1) Hill Top was charged with failing to pursue the lure with due commitment. Mr. Boots pleaded guilty to the charge, Hill Top was found guilty and suspended for 28 days at Shepparton and must perform a Satisfactory Trial in accordance with GAR 69A(2) and pursuant to GAR 72, before any future nomination will be accepted.</p> |

Ziping Pietra and Irongate collided on the home turn.

Chasing Honey underwent a post-race veterinary examination and was found to have split webbing to the left hind paw and a laceration to the left fore limb. A 7 day stand down period was imposed.

Blueberry Hill underwent a post-race veterinary examination and was found to have a left pencil muscle injury. A 7 day stand down period was imposed. Stewards spoke to Faye Wilkinson, the Trainer of Blueberry Hill regarding the greyhound's injury. In accordance with GAR 75 (1), the Stewards requested Ms Wilkinson to report as soon as practicable anything that may have affected the running of Blueberry Hill in the event, which was not noted by Stewards during or immediately after the event. Ms Wilkinson subsequently advised that the greyhound had developed a torn monkey muscle and was receiving relevant veterinary care.
