Stewards spoke to representative, Ms Deborah Coleman regarding the greyhound's racing manners approaching the winning post. Acting under the provisions of GAR 69B(1), Reiko Flash was charged with failing to pursue the lure with due commitment (by reason of injury). Ms Coleman pleaded not guilty to the charge, Reiko Flash was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B(1) and GAR 72, before any future nomination will be accepted.</p>
