Stewards spoke to Kennel Representative Ms Korie-Lee Heinrich regarding the greyhound's racing manners in the home straight. Acting under the provisions of GAR 69(1), Verdun Bale was charged with marring. Ms. Heinrich pleaded guilty to the charge and Verdun Bale was suspended for 28 days at Sandown and must perform a Satisfactory Trial in accordance with GAR 69(2) and pursuant to GAR 72, before any future nomination will be accepted.</p>
Race 11 GIDDY-UP 10:30 pm 515m Grade 5	<p>My Neo was quick to begin. Sierra Foxtrot went up with the lids and was very slow to begin (3 lengths).</p> <p>Aragog crossed in approaching the first turn. Gotham Baroness checked off My Neo on the first turn checking Postman Pickett. Sierra Foxtrot raced wide in the back straight. Sierra Foxtrot and Zing On collided in the home straight.</p> <p>Sierra Foxtrot underwent a post-race veterinary examination and was found to have abrasions to the left front leg and left hind foot. A 3 day stand down period was imposed.</p>

Alfie Moon underwent a post-race veterinary examination at the trainer's request and was found to have a right nostril lacetaion. A 5 day stand down period was imposed.

Send Me Dizzy faltered entering the back straight and lost ground

Send Me Dizzy underwent a post-race veterinary examination and was found to have left shin soreness and a left shoulder injury. A 14 day stand down period was imposed. Stewards spoke to Trainer Mr. Jake Dean regarding the greyhound's performance entering the back straight. After hearing evidence from Mr. Dean, viewing all the available race footage and acting on their observations, Stewards were satisfied that the injury suffered by the greyhound was an acceptable explanation for its racing manners and took no further action.
