Ms. Ragen pleaded guilty to the charge, Tall Poppies was found guilty and suspended for 90 days at all Tracks and must perform a Satisfactory Trial in accordance with GAR 69A(2)(a) and pursuant to GAR 72, before any future nomination will be accepted.
