Mohinga Chase crossed to the rail on the second turn and collided with Fernando Cazz, causing Fernando Cazz to collide with Affair Bit, checking Fernando Cazz and Dreamers Lie. Fernando Cazz checked off Affair Bit on the third turn. Wizardry Magic checked off Affair Bit on the third turn and collided with Fernando Cazz, severely checking Wizardry Magic. Fernando Cazz and Dreamers Lie collided entering the back straight severely checking Fernando Cazz and causing Dreamers Lie to fall. I'm Easy Boys and Brady's Shout collided on the home turn.
