Mr Whybrow pleaded guilty to the charge, Mischief Lass was found guilty and suspended for 28 days at Shepparton and must perform a Satisfactory Trial in accordance with GAR 69A(2) and GAR 72, before any future nomination will be accepted.</p> <p>A post-race sample was taken from Mountain Stew - the winner of the event.</p>
