Mr Robertson pleaded guilty to the charge, Pumpkin Pete was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B(1) and GAR 72, before any future nomination will be accepted.</p> <p>White Nikita underwent a post-race veterinary examination at the trainer's request and was found to have spike wounds to the right hindleg toes. A five day stand down period was imposed.</p> <p>A post-race sample was taken from Champ Cheese – the winner of the event.</p>
