Race 1

In accordance with the GRV Hot Weather Policy, this meeting was deemed 'Heat Affected'. At the commencement of kennelling, the outside temperature was 29.0 degrees and the kennel temperature were 18.0 degrees. The Stewards continually monitored the temperature at the venue as per the GRV Hot Weather Policy.

Extreme Force underwent a post–race veterinary examination and was found to have a left hindleg quadriceps injury. A seven day stand down period was imposed. Stewards spoke to trainer, Mr A. Debattista regarding the greyhound's racing manners approaching the second turn. Acting under the provisions of GAR 69B(1), Extreme Force was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Debattista pleaded guilty to the charge, Extreme Force was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B(1) and GAR 72, before any future nomination will be accepted.
