Trainer Mr Michael Meyer was questioned regarding the manner in which he boxed the greyhound Flying Sonic. After considering the evidence from Mr Meyer, Steward at the start and the starter, Mr Meyer was advised to modify his boxing technique as to not leave any area for questioning.
