At the commencement of kennelling, the outside temperature was 35.6 degrees and the kennel temperature was 17 degrees. The Stewards continually monitored the temperature at the venue as per the GRV Hot Weather Policy.

Mr. Pursell pleaded guilty to the charge and Grace's Spirit must perform a Satisfactory Trial in accordance with GAR 69B (1) and GAR 72, before any future nomination will be accepted.
