Mr Harding pleaded not guilty to the charge, Giant's Flash was found guilty and suspended for three months at all tracks and must perform a Satisfactory Trial in accordance with GAR 69A(2) and pursuant to GAR 72, before any future nomination will be accepted.

Mohinga Chase underwent a post-race veterinary examination at the trainer's request and was found to have a right hindleg torn nail injury. A five day stand down period was imposed.
