Ms. Sullivan pleaded guilty to the charge, Zanzibar Icon was found guilty and suspended for 28 days at Shepparton and must perform a Satisfactory Trial in accordance with GAR 69(2) and pursuant to GAR 72, before any future nomination will be accepted.</p>

A 90 day stand down period was imposed.</p>

Speedy Lemon – New declared weight of 34.2kg, last raced at 32.7kg.  A pre-race sample was taken from Dundas Houdini.  Dundas Houdini was quick to begin. Lilly Patch was very slow to begin (6L).  Dundas Houdini, Lavish Pearl, Speedy Lemon and Meatball Soup collided on the first turn checking Dundas Houdini, Lavish Pearl, Blue Magic Opal, Speedy Lemon and Ramona.
