At the commencement of kennelling, the outside temperature was 30.7 degrees and the kennel temperature was 18.7 degrees. The Stewards continually monitored the temperature at the venue as per the GRV Hot Weather Policy.</p> <p>Classic Moment was slow to begin.</p> <p>Jean Crisp and Inga Leah collided on the first turn checking Inga Leah. Felonious Gru raced wide on the home turn and turned its head to the outside towards Natural Image, Felonious Gru collided with Natural Image, checking both greyhounds. Natural Image and Felonious Gru collided several times in the home straight.</p> <p>Felonious Gru underwent a post-race veterinary examination and was found to have a left wrist sprain, a 14 day stand down period was imposed.
