Mr. Crawford pleaded guilty to the charge, Sir Champ was found guilty and suspended for 28 days at Sandown and must perform a satisfactory trial in accordance with GAR 69A(2) and pursuant to GAR 72, before any future nomination will be accepted.

Stewards spoke to trainer, Mr Mathew Wright regarding the greyhound's racing manners on the home turn. Acting under the provisions of GAR 69B (1), Purple Storm was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Wright pleaded guilty to the charge, Purple Storm was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and pursuant to GAR 72, before any future nomination will be accepted.
