Miss Faberge underwent a post-race veterinary examination and was found to have no apparent injury. Ms Angela Langton declined the option to have the greyhound re-vetted. Stewards spoke to Ms Langton, the trainer of Miss Faberge regarding the greyhound's racing manners soon after the start and again entering the back straight. Acting under the provisions of GAR 69A (1) Miss Faberge was charged with failing to pursue the lure with due commitment. Miss Langton pleaded guilty to the charge, Miss Faberge was found guilty and suspended for 28 days at Sandown and must perform a Satisfactory Trial in accordance with GAR 69A (2) and pursuant to GAR 72, before any future nomination will be accepted.
