Race 2 GREYHOUND ADOPTION PROGRAM 11:37 am 300m Maiden	<p>Pursuant to GAR 104 (7), Steward D. Barber did not act in any official capacity for this event.</p> <p>Sarah Beauty - Trainer Mr. Kevin Turchett was fined \$50.00 pursuant to GAR 33(4) for failing to produce the greyhound's registration card. A post-race sample was taken.</p> <p>Dark Knight - slow to begin.</p> <p>Crimson Onyx - raced ungenerously from the 150m mark. Stewards spoke to Trainer Mr. Leland Medcraft regarding the greyhound's racing manners. Mr. Medcraft advised Stewards that the greyhound had previously only trialled solo and that this was its first time coming up against a field. Stewards took Mr. Medcraft's evidence into consideration and placed weight on the fact that the greyhound was inexperienced and having its first start. A warning was issued regarding the greyhound's racing manners.</p>

Stewards spoke to Mr. Robert Le Sueur, the trainer of Golden Go regarding the greyhound's racing manners at the 150m mark. Acting under the provisions of GAR 69(1), Golden Go was charged with marring. Mr. Le Sueur pleaded guilty to the charge and Golden Go was suspended for 28 days at Healesville and must perform a Satisfactory Trial in accordance with GAR 69(2) and pursuant to GAR 72, before any future nomination will be accepted.</p>
