Stewards gave the greyhound the benefit of the doubt and took no further action. Mr. Langley further advised Stewards that he believes the greyhound may be better suited to a straight course as it gets closer to retirement.</p>

Stewards took into consideration Mr. Galea's evidence and were satisfied that in colliding with the tiring Wild One Mikado, Lady Rozina Hook had not breached any of the relevant rules of racing. No further action was taken.

Wild One Mikado - quick to begin. Collided multiple times with Lady Rozina Hook entering the home straight and tired over the concluding stages.
