Stewards spoke to Mr. David Phillips regarding the racing manners of Warm Beer. Taking into consideration the close proximity of the incident to the winning post as well as evidence given by Mr. Phillips, Stewards were of the opinion that the greyhound's racing manners were not severe enough to warrant a charge under the relevant rules of racing. Subsequently, a warning was issued and Stewards advised that they will be closely monitoring the greyhound's actions at future starts.</p>

After considering the evidence, Stewards charged Mr Formosa with a breach of GAR 86(o) in that he negligently failed to ensure the greyhound Footy Trip Fund was properly secured at all times. Mr Formosa pleaded guilty to the charge and was fined \$100.</p>
