MEETING COMMENTS:

Satisfactory trial results - Tail Light trialled over the 390m from box 1, weight 30.1kg , the greyhound was placed 3 in a field of 4. The time of the trial was 22.18, the greyhound was beaten by a margin of 14 lengths. Tail Light was cleared.

Major Crush trialled over the 390m from box 3, weight 28.9kg , the greyhound was placed 1st in a field of 4. The time of the trial was 22.18, the greyhound won by a margin of 7.5 lengths. Major Crush was cleared.

Major Threat trialled over the 390m from box 5, weight 29.6kg, the greyhound was placed 4th in a field of 4. The time of the trial was 22.18, the greyhound was beaten by a margin of 15. Major Threat was cleared.
