Club staff were reminded of their responsibilities to correctly kennel greyhounds. This incident was reported to the Club Manager for further consideration.</p> <p>Handler Ms J. McQuillen was issued a warning pursuant to GAR 86(o) in that she negligently presented Marshall Gible to race wearing the incorrect rug.</p> <p>Marshall Gible, Exit Sign and Fernando Flop were quick to begin.
