After hearing a submission from Mr. Gibbons stewards found him in breach of GAR 86(o) in that he negligently failed to retrieve the greyhound from the kennels prior to leaving the course. In assessing penalty, stewards took into account Mr. Gibbons guilty plea, his remorse over the incident and his good record in respect to similar offences and accordingly imposed a fine of \$100.00.
