Stylish Ken underwent a post-race veterinary examination and was found to have a laceration to the left elbow. A 14 day stand down period was imposed.

After hearing evidence from Mr Meyer, viewing all the available race footage and acting on their observations, a warning was issued regarding the greyhound's racing manners soon after the start.
