Mr Briganti pleaded guilty to the charge, Living The Lie was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B (1) and pursuant to GAR 72, before any future nomination will be accepted.

Mt. View Bee underwent a post-race veterinary examination and was found to have an injury to the right monkey muscle and split webbing to the left front and left rear. A 14 day stand down period was imposed. Stewards spoke to Mr David Kerr, the handler of Mt. View Bee regarding the greyhound's racing manners on the second turn. Acting under the provisions of GAR 69(1) Mt. View Bee was charged with marring. Mr Kerr pleaded guilty to the charge, Mt. View Bee was found guilty and suspended for 28 days at Cranbourne and must perform a Satisfactory Trial in accordance with GAR 69(2) and pursuant to GAR 72, before any future nomination will be accepted.

Unravel underwent a post-race veterinary examination and was found to have injuries to the right monkey
