Upon review of all the footage available, Stewards could not be comfortably satisfied that Dutch Impact had made muzzle contact with Ravenna Bale on its inside. Acting under the provisions of GAR 69B (1), Dutch Impact was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Kirk pleaded guilty to the charge and Dutch Impact must perform a Satisfactory Trial in accordance with GAR 69B (1) and pursuant to GAR 72, before any future nomination will be accepted.

Easy Street underwent a post-race veterinary examination and was found to have minor abrasions to the left foreleg. No stand down period was imposed.
