Acting under the provisions of GAR 69A (1) Barellen Pearl was charged with failing to pursue the lure with due commitment. Mr King pleaded not guilty to the charge, Barellen Pearl was found guilty and suspended for 28 days at Ballarat and must perform a Satisfactory Trial in accordance with GAR 69A (2) and pursuant to GAR 72, before any future nomination will be accepted
