Stewards spoke to trainer, Mr Chris Constantinou, regarding the greyhound's racing manners approaching the winning post. Acting under the provisions of GAR 69B(1), Inga Meg was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Constantinou pleaded guilty to the charge, Inga Meg was found guilty and must perform a Satisfactory Trial in accordance with GAR 69B(1) and GAR 72, before any future nomination will be accepted.

Due to further heavy rainfall the Stewards inspected the track and deemed the surface unsatisfactory for

rating, the race meeting was abandoned at 4:53pm
