A 5 day stand down period was imposed. Stewards spoke to Trainer Mr. Jason Thompson regarding the greyhound's racing manners entering the home straight. Acting under the provisions of GAR 69(1), Anticipating was charged with marring. Mr. Thompson pleaded guilty to the charge, Anticipating was suspended for 28 days at Ballarat and must perform a Satisfactory Trial in accordance with GAR 69(2) and GAR 72, before any future nomination will be accepted.</p>
